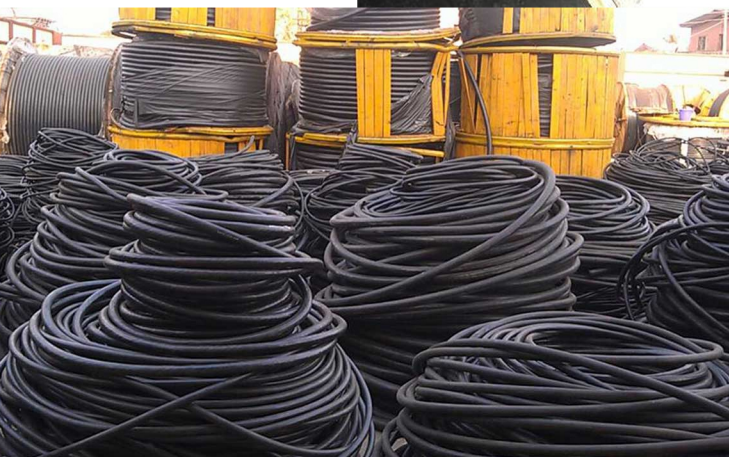




Power
